Dear RSFI member/Prospective member,

The RSFI looks forward to welcoming you to the 2011/2012 membership year. Please be advised that the yearly membership fee is Rs.3000/- for existing members and Rs. 5000/- for new members.

Since 2010 every state should submit fresh affiliation request with complete documents, it is not automatic renewal. Filled application should reach RSFI office before March 18th 2011. Affiliation request through fax or email will not be accepted. It will be the responsibility of State association to deliver the complete application and documents by courier or by post. RSFI will not be responsible for loss of application in transit

Late delivery of application/incomplete application or delay in cheque processing will be sole responsibility of state association and RSFI will be free to take any decision/action thereafter.

State associations are advised to send Demand Draft to avoid delay of cheque clearing. Affiliation will be considered only if the cheque is cleared or you have to send a DD of full amount on the name of Rope Skipping Federation of India, payable at New Delhi and previous dues, if any.

Partial payment or incomplete documents will not be accepted and state association would not be able to claim for their membership for the year 2011 -2012. In that case RSFI may ask for fine if the affiliation for your state is not given to any other organization.

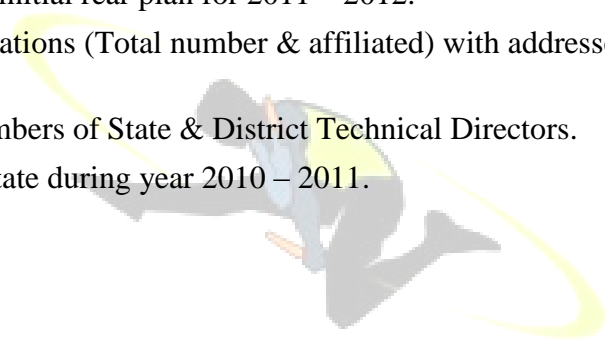
